Tournament Rules

Entry Fee: \$100/boat and \$75/Kayak per person to be submitted by **June 9, 2010**.

This is a team event consisting of 1-4 members for the boat division and 2 man teams in the kayak division.

All team members must be named on the registration form.

Individual registrants needing a team will be given the opportunity to join others if possible.

1. Fishing begins at safelight (30 minutes before official sunrise)(Lines in the water).
2. Eligible fish are 2 trout and 2 redbfish. Kayaks weigh in 2 fish, any combination.
3. PARKS AND WILDLIFE FISHING LICENSE AND SALTWATER STAMP ARE REQUIRED. ALL PARKS AND WILDLIFE RULES AND REGULATIONS WILL BE ENFORCED. IT IS ENCOURAGED TO WEAR PERSONAL FLOTATION DEVICES AT ALL TIMES.
4. All waters may be fished by boats, kayaks, docks, piers and wade fishers.
5. Fishing teams must stay within sight of each other at all times.
6. In event of a weigh tie, length will prevail. Decisions of the weigh master are final.
7. "One Pole per Angler"- You can have more than one rod and reel on the boat, but you cannot fish with more than one at a time.
8. Tournament is open to live or artificial bait.
9. Guides are welcome but must be counted as part of the team.
10. Weigh in no earlier than 1pm and you must be in sight of the Weigh Master by 3 pm. 1pm weigh-in start time is tentative, subject to change.

Clarification of Rules

* Redfish - A legal Redfish (Red Drum) must be at least 20" and not greater than 28". No Redfish over 28" will be considered for any division.

* Trout - A legal Trout (Spotted Sea Trout) must be at least 15". You can weigh in one trout over 25" per team.

* Hard head Catfish – (Not a Gaff-top Sail Catfish!) Do not bring a slimy gaff-top with trimmed fins to the Weigh Master. You will be laughed at, chastised and flogged! There is no minimum or maximum length Hard Head.
